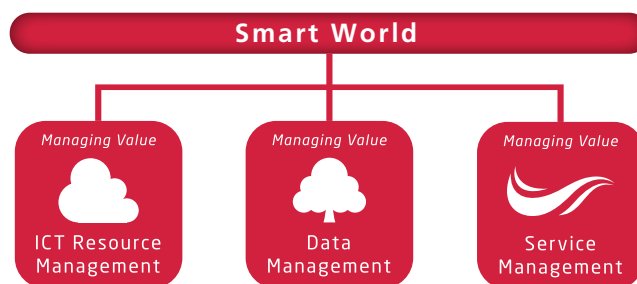

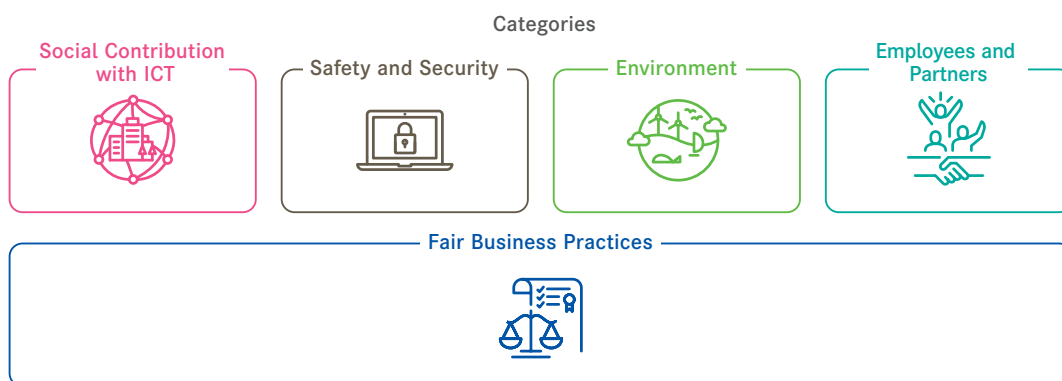

## Sustainability Policy

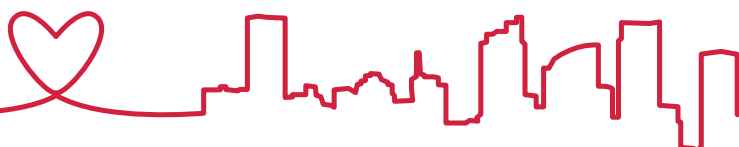

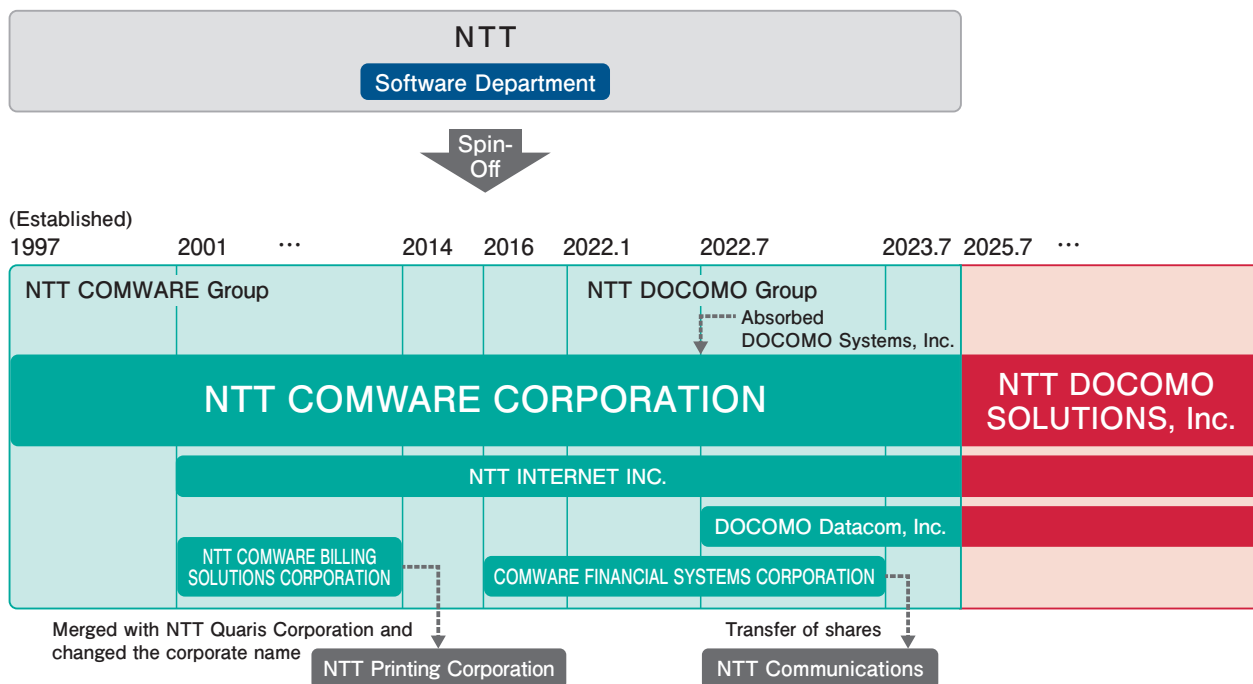

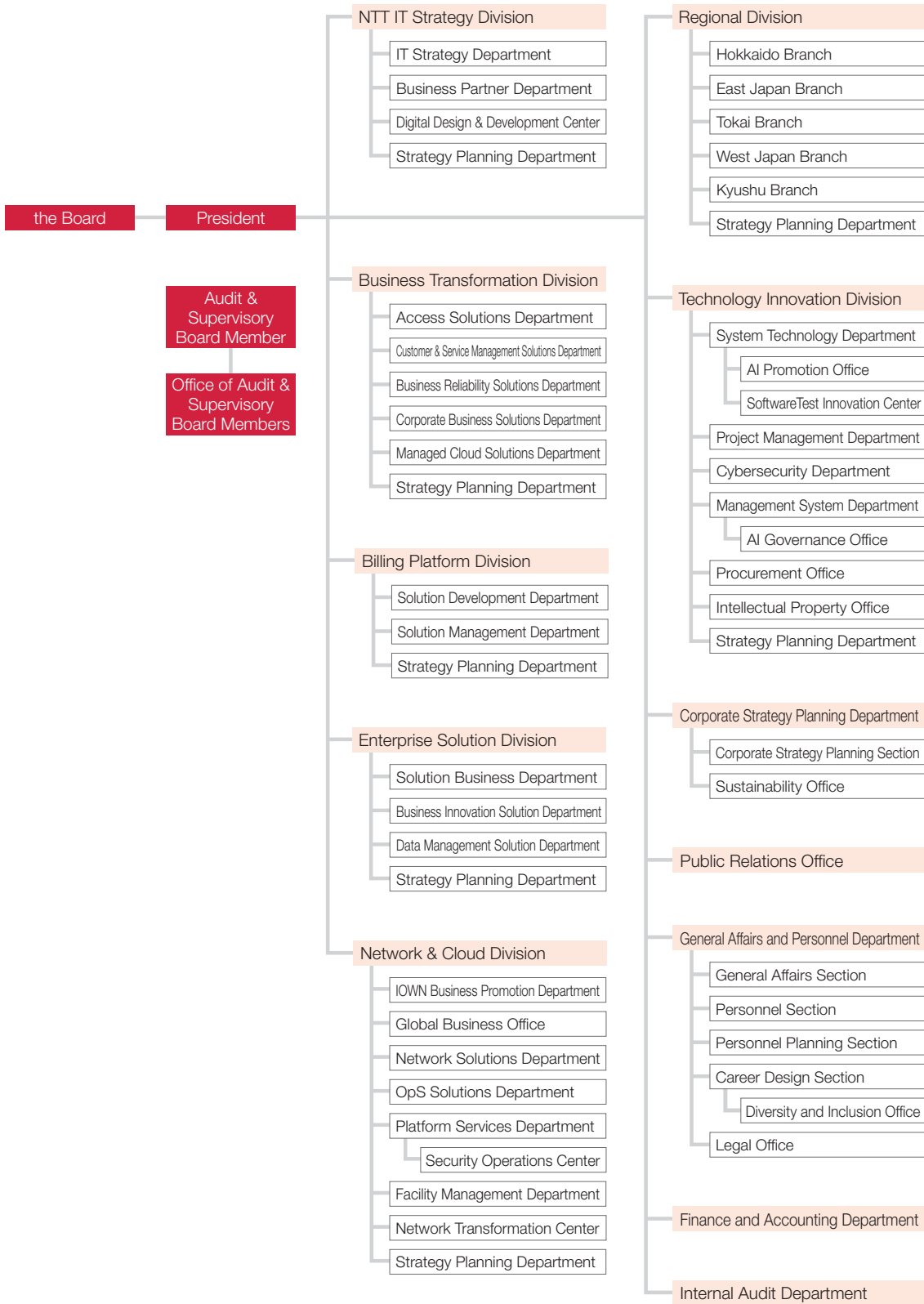
